Client Agreement

This is an agreement between Boone Investigative Services, and _____, hereafter referred to as CLIENT. The parties agree Boone Investigative Services shall provide CLIENT with private investigative services which may result in: written report, recorded statements, printed documents, photographic evidence, videotape evidence and related materials, as set forth by the terms and conditions below. CLIENT agrees to pay Boone Investigative Services an hourly rate, listed below, plus necessary and reasonable expenses with a four hour minimum. Twenty-four hour notice is required in the event of a cancellation; otherwise your account will be invoiced for four hours for each investigator scheduled for that day. Request for immediate surveillance (less than 24-hour notice) will be at double time for the first four hours, regular rate thereafter. Major holidays and certain holiday weekends are invoiced at double time; eight hour minimum. Expenses may include, but are not limited to; mileage, parking, rental vehicles, data base searches, tolls, meals and hotel. Receipts will be obtained for individual expenses exceeding \$25.00 and/or where deemed appropriate.

CLIENT authorizes Boone Investigative Services to use their best judgment while on surveillance in determining when to discontinue surveillance. Any unpaid balance must be remitted within 7 days of notice. A surveillance event cannot be scheduled unless all unpaid balances have been paid. Boone Investigative Services has the right to refuse any requests for surveillance, at any time, without prior notification or reason. Boone Investigative Services warrants CLIENT that the services shall be performed with a degree of skill and care that is required in conformance of accepted professional standards and practices in the private investigative industry. Boone Investigative Services further acknowledges that in performing private investigative services that it will comply with all applicable local, state and federal laws. Except as specifically provided above, Boone Investigative Services disclaims all other warranties, expressed or implied. All investigative reports, information, tapes, or documents, provided to the CLIENT are to be considered exclusive in nature. CLIENT agrees to restrict the dissemination of said findings to only third parties with legitimate need to know or those authorized by law.

Due to certain circumstances and/or individual behavior patterns, Boone Investigative Services promises only due diligence in resolving the investigation to the CLIENT's satisfaction. We cannot guarantee that vehicles will not be lost in traffic, or that the person being followed will not become aware of our investigators.
